A Year in Review: This Year Had it All

Advocacy, law reform, composition of the judiciary and radical change to our Sections - this year had it all.

Ask the nearly 7,000 members in BC what they value in their CBA membership and the answers will vary greatly. Meeting the varied needs and interests of our members must be at the forefront of the CBABC's activities year-round. As the 2013-2014 year draws to a close, I thought it appropriate to highlight some of the year's events and where we are headed in the months to come.

Advocacy and law reform. We had a string of successes in building allies in our advocacy for enhanced and stable funding for legal aid and the Court Services Branch. First up in September was the Union of BC Municipalities, which called for long-term, increased and stable funding of legal aid.

In November, the Select Standing Committee on Finance and Government Services adopted the CBABC submissions and recommended that the government commit to stable funding for the Court Services Branch and increases to legal aid.

In May, the delegates to the AGM of the BC Chamber of Commerce unanimously adopted the resolution of a joint CBABC/Chamber task force calling for commitments to funding of legal aid and the Court Services Branch and for

the establishment of a formula to determine the proper number of Provincial Court Judges.

Throughout the year, the Legislation and Law Reform Committee and our many Sections made submissions to government on law reform. Topics varied from local government election reform and a proposed Franchise Act to regulation of other legal service providers such as notaries and paralegals.

Excellence and diversity in the judiciary. Members of CBABC's Advisory Committee to Judicial Council make reports on all applicants who apply for a position with the Provincial Court. These reports are the primary source of information for assessing the suitability of applicants and for deciding whether Judicial Council grants an interview. The CBABC performs an invaluable service to the profession, the judiciary and the public.

We have also been focused on diversity in the judiciary, and in late May held a very successful forum, webcast across the province, "Building Diversity on the Bench." Several judges spoke from their own experiences and why both diversity and excellence in judicial appointments are so important.

It has been a pleasure and privilege to serve as President.

Professional Development and Sections

The CBABC is committed to offering its members a full range of professional development opportunities that provide a valuable skills-improvement forum and a platform to exchange ideas with colleagues. Professional Development (PD) and Sections are great opportunities to network and attain the required continuing professional development hours. The 2013/2014 was a successful term producing many well attended events, seminars, and conferences.

PROFESSIONAL DEVELOPMENT

CBABC Professional Development has had a highly active term, offering a total of 50 courses, 27 held by webinar and 23 in-person. Throughout the course of the year, PD awarded 132.50 hours of continuing professional development (CPD) in accredited educational activities.

PD partnered with local/county bar associations to hold five full day Seminars in Abbotsford, Prince George, Nelson, Smithers, and Courtenay, BC, for a total of 29 hours of CPD. Several Sections also partnered with PD on 4 events. The Solicitors' General Practice – Central Vancouver Island Section, Labour Law Section, Criminal Justice – Vancouver, and the Wills & Trusts – Vancouver, Victoria, and Okanagan Sections all held conferences/events with PD for a total of 11 hours of CPD.

In total, PD had over 2000 registrations this term, 800+ by in-person attendance alone, and a staggering 1200+ by webinar. Of most noteworthy was PD's follow-up on its highly popular *Wills, Estates and Succession Act (WESA)* live webinar in the previous summer. PD hosted three 2 hour seminars in Victoria, North Vancouver, and Kelowna in response to the feedback reached from CBA members and non-member alike.

CBABC PD introduced its first ever E-Learning On-Demand online modules, incorporating reading materials, quizzes, audio and video. Counting for 1 CPD hour each, PD rolled out "Introduction to Ethics and Professional Responsibility in BC" in 2 modules, covering *Canons of Legal Ethics and Client Care* and *Administration of Justice, Supervision, The Profession* respectively.

SECTIONS

This year 4810 enrolled members attended 395 Section meetings, 47 of which were hosted as social events. 467 Section Executive Officers volunteered their time this term in order to support the highly active 78 Sections, with more than 11,000 Section enrollments taking place. Throughout the course of the year, the CBABC awarded 365 hours of continuing professional development (CPD) in accredited educational activities.

In the spirit of cooperation and mutual collaboration, 23 meetings were held as joint ventures this term, hosted by 2 or more Sections. Looking to increase its outreach, the CBABC increased member participation and engagement by working with Sections to promote the use of high-speed broadband and wireless networks to its advantage by hosting more remote meetings. Of these CPD eligible meetings, 170 were held by remote participation; 123 by Webinar and 47 by Teleconference. The CBABC received upwards of 7,900+ in-person registrations and an overwhelming 1,400+ remote registrations over the course of the year.

The CBABC welcomed the newly formed Young Lawyers – BC North Section this term, who had a successful first year. Hosting 4 events, the Section promoted their mandate to endorse the retention of young lawyers in the BC North region.

President's Medal

This year, the CBABC President's Medal was awarded to Tino Di Bella of Jawl Bundon in Victoria.

Mr. Di Bella is the chair of the British Columbia Law Institute and a past chair of the CBABC's Legislation and Law Reform Committee. In making the award to Mr. Di Bella, President Crawford said, "I can think of no lawyer in British Columbia who has committed as many volunteer hours to the important work of law reform. He is a most deserving recipient."

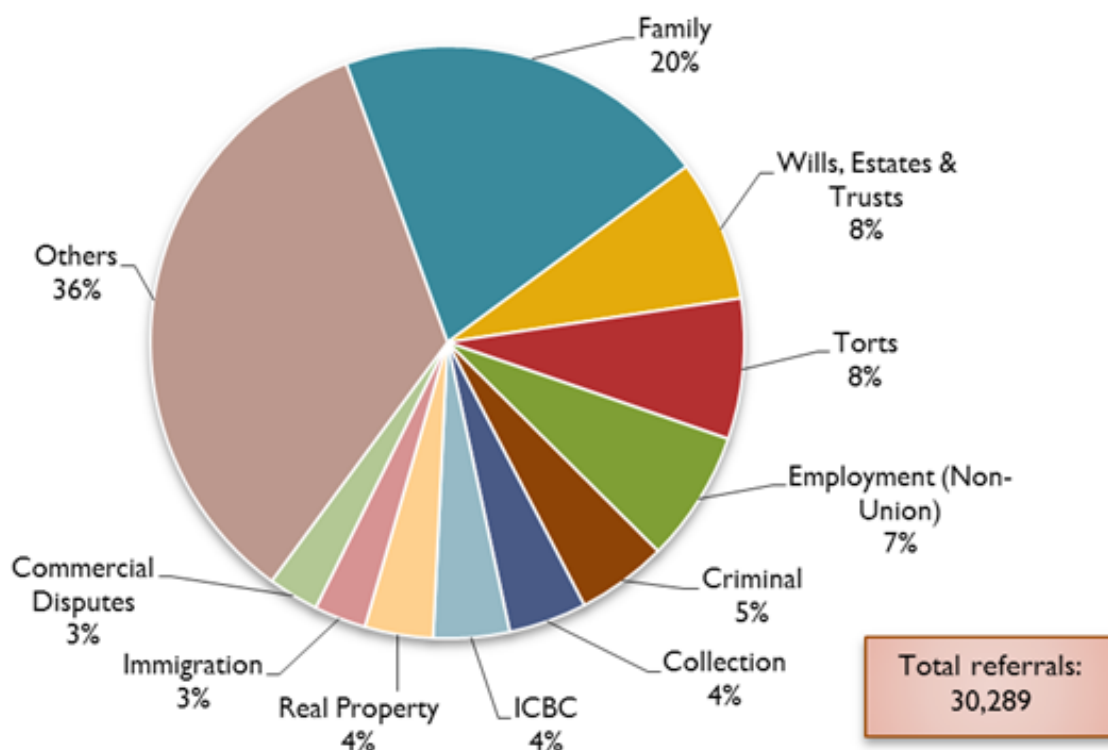
The Lawyer Referral Service and Dial-A-Law

The Lawyer Referral Service (LRS) was established in 1955 in British Columbia to assist those in the community seeking legal representation. This unique service assists the people of province in locating lawyers for specific types of legal matters. The LRS operates by matching potential clients to a member of the Lawyer Referral Service panel for free. LRS will refer the client to a participating lawyer with whom they may consult for up to 30 minutes. The lawyer may provide the consultation for free or charge a minimum \$25. After the brief consultation the client and the lawyer decide whether or not the lawyer will be retained to provide additional services at the lawyer's regular rates.

Each year, thousands of clients are referred to lawyers through the LRS. Members and non members of the Canadian Bar Association, BC Branch may join the Lawyer Referral Service panel for free and have access to the referrals. Many of the lawyers registered on LRS volunteer to update the Dial-A-Law (DAL) scripts that are available to the public for free by telephone and online (audio format available). DAL is a library of practical information on specific topics of law. Scripts are available in English, Punjabi and Chinese.

Law Week in British Columbia

Law Week is an annual public legal education program that provides an opportunity for young people and adults to become familiarized with the Canadian legal system. Law Week 2014 showcased the legal community through in-person live events throughout British Columbia, such as mock trials, interactive displays and courthouse tours, and online with a vibrant social media presence.

Law Week's theme for 2014 was *Access to Justice: What Does it Mean to You?* This year, nine locations across British Columbia participated in celebrating the 32nd Anniversary of the Charter of Rights.

Vancouver Law Week activities started early with the "Meet the Chiefs" student forum with the three Chiefs and more than 100 students hosted by CBC's Ian Hanomansing. The "Judges in the Classroom" student outreach program matched judges with high school classes. There was a greater focus on public education in 2014. There was a campaign to encourage the public to check their legal health online. Public education classes were coordinated across the lower mainland for a total of 14 classes with almost 400 people in attendance. Three "sold-out" courthouse tours took place on Law Day beginning in the Justice Education Centre, moving to the Provincial Court, Court of Appeal, and the Supreme Court. Attendees listened to presentations from the JEC, Provincial Court staff, a Supreme Court Judge, Sheriffs, and Court Registry.

Volunteer lawyers assisted approximately 300 people during the Province-wide annual "Dial-A-Lawyer" event, held on Saturday,

April 12, in various areas of law (an increase of almost 20% of incoming calls from 2013). BC residents were invited to call and speak with a lawyer for up to 15 minutes at no cost.

The 2014 Barry Sullivan Law Cup Public Speaking competition was held in the heritage courtrooms at the Vancouver Art Gallery. Over thirty students presented five minute speeches that pertained to the theme "Access to Justice: The Role of law in the Digital Age." Ciara O'Leary of Little Flower Academy took home the top honour, receiving a trophy along with a \$1,500 cash prize.
