Working Hard at the First Annual ALF Spa & Golf Retreat

On Saturday morning, we started the program early with a delicious breakfast and a presentation by Michelle Good of Sage Law. Michelle works with residential school survivors and spoke about the legacy of the residential school system. Next to present was Kelly Russ on the topic of Indian Band Governance and Human Rights. Kelly explained the application of the (Canadian Human Rights Act) to Indian Bands, Band Councils and the Federal Government and how new legislation is going to change how governance is conducted within Indian Bands and the Federal Government. Rosalie Wilson, Mentorship Program Developer for the Law Society of BC presented on her work developing

the Law Society's Aboriginal Mentorship Program. Rosalie was followed by a lively presentation by CBIA representative Dustin Serviss. (I'm not kidding, we kept Dustin on his toes!) Our lunchtime presenter was Grant Christoff of the Department of Justice speaking on the hot topics in Aboriginal rights and title. It was then time to break for spa sessions and tee times. The rest of the afternoon was spent either being pampered at the Le7Ke Spa or playing the majestic and challenging Talking Rock Golf Course. UBC Indigenous Law Students Association Update

Te, the students in the Indigenous Law Students' Association (ILSA) at UBC Law, a facet of the Law Students' Society (LSS), recognize that great strength lies in embracing the diversity that exists within the collective of brilliant individuals who comprise the legal profession we aspire to join.



ILSA thanks the CBABC and its ALF Executive whose thoughtful and well-organized social and educational initiatives foster respect for plurality and inclusion of all members. ILSA believes that if law students, regardless of race or creed, can work collaboratively with one another and achieve shared success, when we graduate and begin assisting our clients, whether private or public, reconciliation will ensue.

How does ILSA transform the status quo at UBC Law? Its team of approximately 60 students work together, each utilizing a unique skill set, to organize and participate in forums that bring together those interested in gaining knowledge about practical and theoretical Aboriginal legal issues in a manner that builds trusting relationships. In early 2012, Faculty, in collaboration with the LSS and ILSA, voted in favor of introducing a specialized module on Aboriginal and treaty rights for first year constitutional law, to be taught by the school's Indigenous legal scholars (http://www.law.ubc.ca/faculty/faculty_research.html). This initiative exceeds the new standards set by the Federation of Law Societies of Canada and

supports our claim that UBC Law, which provided the first Aboriginal law course in Canada, leads the nation with respect to the breadth and depth of its course offerings in this vital area of the

law.

In response to the inclusion of Aboriginal and treaty rights in first year curriculum, on February 27, 2012, ILSA presented Faculty with the 1st Annual Courage in Law Award. The award was presented to Associate Dean David G. Duff and to incoming Associate Dean, Benjamin J. Goold, both of whom worked hard to bring this initiative to fruition. LSS President Roni Jones and Andrea Hilland, from the First Nations Legal Students Program, also received awards on behalf of their respective groups.

Following the award presentation, ILSA invited students and Faculty to participate in 2012 Aboriginal Awareness Week activities. Events included an opening ceremony with drumming and dancing, the



annual ILSA/Fasken Martineau spring BBQ, a lecture from Grand Chief Ed John - North American Representative to the United Nations Permanent Forum on Indigenous Issues, eagle feather beading, a film screening of Cry Rock and a lecture from Professor Gordon Christie on liberal understandings of Aboriginal rights.

With all this momentum, the LSS saw need to strengthen the role of its Director of Aboriginal and Academic Issues, a position which Christina Cook and her peers created in 2009. At the Spring AGM, the general body of law students voted in favour of constitutional amendments that enabled a new position on the LSS Executive to be created – the Executive Director of Indigenous Perspectives and Student Development (EDIPSD). Going forward, the EDIPSD will inter alia provide an Indigenous voice and perspective within the LSS and Faculty committees, while working with fellow LSS Executive members to develop initiatives that foster non-Indigenous students' recognition and respect for indigeneity at UBC Law, which we see benefiting the profession as a whole.

Thompson Rivers University Faculty of Law – Indigenous Law Students Association Update

t was a busy year for the indigenous law students at Thompson Rivers University. On Sept. 6, 2011 Thompson Rivers University Faculty of Law welcomed 75 new students to an academic program. The TRU Law Program has a particular focus on First Nation and Aboriginal legal issues. On Oct. 25, 2012 the Indigenous Law Students' Association ("ILSA") was born. Our mission is to "facilitate opportunities unique to Indigenous law students". Our objectives are to encourage and promote the development of a community of academic, professional and social support among Aboriginal students in the TRU Faculty of Law; Represent and support the academic and professional interests of Aboriginal students at the TRU Faculty of Law; and promote accessible legal education for Aboriginal people in a culturally-sensitive learning environment.



In November the ILSA was pleased to welcome Ruth Thompson, Director of the Native Law Centre in Saskatchewan to TRU for a special presentation and dinner with the students. During November & December the ILSA also worked to draft its constitution, attend and volunteer at the National Restorative Justice Symposium, host culture events including a sweat with a Secwepemc Elder, attend an ALF hosted lunch at with local Aboriginal lawyers, and advocate for an Aboriginal Representative to be appointed to the Student Law Society Executive.

In the New Year, the ILSA participated in various events including a field trip to the Secwepemc Museum & Heritage Park, TRU's Foundation Gala, 1st Annual Sweatlodge with Chief Felix Arnouse of Little Shuswap Indian Band, Kawaskimhon 2012 National Aboriginal Rights Moot in Saskatoon, and the Honouring Our Tiny Tots Pow Wow at TRU gymnasium. The ILSA also held a pre-exam smudge for students at the Gathering Place officiated by Elder Estella Patrick Moller. After completing exams local Aboriginal lawyer Linda Thomas hosted a celebration dinner at her home for all ILSA students. The ALF also hosted a celebration lunch. In May two ILSA students attended the ALF Spa & Golf Retreat at Quuaout Lodge and enjoyed the opportunity to meet Aboriginal lawyers from across B.C. The ILSA continues to be active and is already preparing for the 2012/2013 academic year.
